Resident called on March 19 to inquire about technical permit revision.	Followed up with resident and discussed purpose of revision, zero emission factors, stack height, and clarified that there would be no changes to any permit limits. Resident wanted to make sure that ATSDR had received a copy of the request. Resident also inquired about methyl tertiary butyl ether (MTBE) and whether or not it was in the Intel permit and whether or not Intel was emitting MTBE. The following information was obtained: • MTBE is in Appendix X of the Intel permit as an approved HAP • MTBE is not used or emitted by Intel • MTBE has never been detected in sampling from Intel thermal oxidizer or scrubber stacks • MTBE is not identified by EPA as an emission from the combustion of natural gas or diesel • MTBE was not detected in the Intel fenceline monitoring with integrated
